1. Name of Recital: Reindeer Romp
2. Location of Recital: Bill Medley Auditorium at Santa Ana High School. 520 W Walnut Street, Santa Ana, CA 92701
3. Date/Time of Recital: December 7, 2025* Showtime will be assigned at least one month prior, please reserve the day. *Subject to change.
4. Recital Registration and the Recital Commitment Fee must be completed on or by September 30, 2025. Any registrations and fees permitted after that date may subject the registered participant to additional charges associated with late order processing and/or rush shipping.
5. Recital participants must be enrolled in the same class for all required sessions (September-December). If recital participants are enrolled in a class that consists of multiple consecutive sessions, proof of continued enrollment in the subsequent sessions is required to participate in the recital.
6. Dancers must be checked in 45 minutes prior to showtime. Dancers must remain with their class for the duration of the show. Parents are encouraged to watch the show in its entirety, as no dancers will be released early, no exceptions. Upon conclusion of the show, we will release dancers in show order, class by class. Please send one representative from your party to the check-out area to pick up your dancer.
7. Parents or guardians will not be permitted past the dancer holding area. Authorized and trained staff are the only people who may be with dancers in the holding area. No parent volunteers. Only SoCa Arts background-checked staff is permitted in the holding area. For this reason, relatives, siblings, and/or parents will not be permitted in the holding area.
8. Each dancer's family will receive a professional digital recording of the show approximately 6-10 weeks after the recital. Flash photography and video recording are not permitted for safety and due to auditorium policies. Tripods will be asked to be taken down and guests asked to remain in seats as to not obstruct other patrons' view of the show. Non-flash photography is permitted throughout the show.
9. For safety and privacy concerns, the digital recording of the show is not to be shared on social media or other public, online platforms except by Elysian Arts & Events, LLC ("SoCa Arts") and/or its designees.
10. The Recital Commitment Fee of \$89 is non-refundable and must be paid online on or by September 30, 2025. The Recital Commitment Fee is \$59 for boy participants (costumes) who provide their own top or pants (SoCa Arts will provide other costume pieces). This one-time payment will be used to purchase a costume and/or props and accessories for the registered participant, in addition to applicable shipping and handling costs. The Recital Commitment Fee also includes a professional digital recording of the show for each family.
11. Families with siblings participating in recital can contact info@socaarts.com after completing registration for their first dancer and receive a \$10 off promo code for additional sibling registration(s).
12. Dancers participating in recital with more than one class can contact info@socaarts.com after completing registration for their first class and receive a \$10 off promo code for additional class registration(s).

13. SoCa Arts is not liable or responsible for any charges associated with insufficient funds. In the event SoCa Arts incurs any such charges, SoCa Arts will pass the charges directly to the account holder plus a \$15 admin fee.
14. In the event the registered participant withdraws from participation in the Recital, cannot participate due to unforeseen circumstances, or the Recital must be postponed or canceled by SoCa Arts for reasons beyond our control, the dancer will still receive the costume and/or props and accessories which were paid for in advance with the Recital Commitment Fee, which shall at all times remain nonrefundable. Pick up is available in-person until session end date. Shipping is available until January 31, 2026, and participant is responsible for all shipping charges. Costumes will be donated if not retrieved in-person by session end date or requested for shipping by January 31, 2026.
15. SoCa Arts will follow all state, local, and venue guidelines related to health and safety measures in place at the time of the recital. These guidelines may change at any time to protect the well-being of the dancers and their families. Non-compliance with these requirements may result in your child being unable to participate. Please ensure your dancer and family are comfortable with any potential health or safety requirements that may be implemented prior to registering. No refunds will be issued for any reason related to health or safety protocols set by state or local authorities. Final day-of policies will be shared with parents via email closer to the recital date, if applicable.
16. Tickets for the Recital can be purchased online in advance for a lower pre-sale price or at the door on the date of the Recital for a slightly raised price, cash only. Tickets purchased during registration will include priority entry. If you choose not to purchase tickets during registration, we will open online pre-sale again approx. 4-6 weeks before the show. Online tickets will only be available for purchase until the Tuesday before the show.
17. Auditorium doors open at least 30 minutes before scheduled showtime. Seats are on a first-come basis. Seat saving will not be permitted, please keep your group together.

Holiday 2025 Recital Waiver & Release from Liability

I hereby acknowledge and agree that the nature and extent of the activities offered by Elysian Arts & Events, LLC ("SoCa Arts") in which my child/guardian/ward (hereinafter "child" or "dancer") will be participating, including but not limited to, dance class, workshop, program, performance, recital, or any other dance related activity (the "Activities"), contain inherent risks of physical injury, property damage, and/or death. In full recognition of these risks, I hereby knowingly and voluntarily agree to assume all risk and responsibility for any and all injuries, accidents, incidents or other mishaps to me and/or my child as a result of my child's participation in such Activities, including all risks reasonably connected with the Activities, whether foreseen or unforeseen. I acknowledge and understand that SoCa Arts assumes no responsibility for any medical expenses, insurance deductibles, copays, injuries, or other damages (whether economic or non-economic) suffered or otherwise incurred by child, myself, or any other third-party as a result of my child's participation in the Activities.

I further acknowledge that the Activities take place at venues SoCa Arts does not own, operate, or control, such as rented halls or event spaces (the "Locations"). I understand and agree that SoCa Arts cannot ensure the physical safety of the Locations. As a result, I hereby agree to accept the Locations "as is." In other words, I agree to accept the Locations in their current condition, with all apparent and non-apparent conditions and defects. I further understand and agree that SoCa Arts cannot control the actions or inactions of third parties who may be present at the Locations. As such, I agree to accept responsibility at the Locations for my own safety, and my child's safety, and to release SoCa Arts from any and all liability associated with any injury, accident, incident, or other mishap to me or my child at the Locations.

In consideration for SoCa Arts allowing my child to participate in the Activities, I further agree to release, defend, indemnify, and hold harmless SoCa Arts, its affiliates, subsidiaries, other partners, and vendors and each of their respective officers, directors, employees, instructors, shareholders, legal representatives, agents, successors, and assigns, from and against any and all demands, claims, lawsuits, damages, liabilities, penalties, costs, expenses (including, without limitation, reasonable attorneys' fees, expert fees, and litigation costs), or causes of action of any kind or character that arise out of, result from, or are otherwise connected with the acts, errors, or omissions, whether intentional or negligent, of my child and/or my child's participation in the Activities at the Locations.

Without limiting the generality of the foregoing, I acknowledge that infectious diseases, illnesses, and public health concerns (including but not limited to COVID-19 and any future or unknown communicable diseases, viruses, or health crises) may pose risks in Orange County and beyond. I understand that, due to the nature of the Activities, it may not always be possible to maintain physical distancing or prevent exposure to such illnesses. I understand and accept both the known and potential dangers of my child's participation in the Activities, including, but not limited to, the risk of exposure to contagious illnesses, which could result in, among other consequences, quarantine requirements, serious illness, disability, and/or death. I represent and warrant that: (i) I am familiar with the general symptoms commonly associated with communicable illnesses; and (ii) my child will not participate in any Activity if, between my execution of this Agreement and the Activity, my child (a) develops symptoms of a potentially contagious illness, (b) receives a confirmed or suspected diagnosis of a communicable disease, and/or (c) knowingly comes in contact with a person who has a contagious illness and/or is exhibiting symptoms of such. I understand that SoCa Arts may implement health and safety guidance and/or protocols to mitigate

the transmission of contagious illnesses, and that such measures may impact my and/or my child's experience. I further understand that SoCa Arts may revise these measures at any time, and that no particular measures are guaranteed. I agree that my child will comply with all such measures while participating in the Activities.

I understand that SoCa Arts may take, or have taken, photographs, video recordings, and/or audio recordings of me and/or my child during Activities for advertising or other business purposes. I hereby consent to SoCa Arts' use of my child's photograph, image, recording and/or other likeness for SoCa Arts' business purposes only, and I further agree to allow SoCa Arts to reproduce and use such photographs, images, likeness, and/or recordings for such purposes. This consent includes, without limitation, the right for SoCa Arts to sublicense, in any media platform or format whatsoever, including for advertising and promotional purposes and to distribute, broadcast and exhibit the foregoing without charge, restriction or liability. I understand that all ownership and intellectual property rights in the foregoing will be owned by SoCa Arts, and I waive any inspection, notice or approval rights therein.

I understand and acknowledge that this event is a non-city sponsored event.

In cooperation with security guidelines, I acknowledge that my dancer must remain with their class for the duration of the entire recital and will be supervised by SoCa Arts staff, and that I may not pick up my dancer before the show conclusion. I agree to these recital security standards and will not hold SoCa Arts liable for the same. I also acknowledge that SoCa Arts has the right to refuse enrollment and/or participation to any participant at any time. Instructors and background-checked staff are supervising at all times; however, your child's specific teacher will be with your child's class and their other dancers during the show. Early check-out is not permitted and cannot be accommodated due to security reasons. I represent and agree that I will not attempt to pick up my dancer before the event's conclusion.

This Agreement (including all policies regarding recital participation) represents the complete understanding between me and SoCa Arts regarding the subject matter contained herein, and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void or unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I represent that I have signed this Agreement without any inducement, assurance or guarantee, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms and conditions of this Agreement.

_____ By signing this Waiver and Release from Liability, I certified that I have read, understood, and voluntarily agree to be legally bound by the terms herein. I further certify that I am the parent, legal guardian, or other responsible person associated with the child being registered.

_____ I consent and agree to all of the terms, conditions, and provisions of this Agreement on behalf of, and for the minor child.

_____ Any claim or dispute arising out of this Agreement or my child's participation in the Activities shall be submitted to binding arbitration with either JAMS or Judicate West in Orange County, California. The decision of the arbitrator shall be final and binding, and judgment thereon may be entered in a court of competent jurisdiction. The party initiating the arbitration shall pay for all unique fees and costs of the arbitration, such as the filing fee and the arbitrator's fees and costs. In any proceeding brought to resolve a controversy arising under or out of this Agreement, the Arbitrator shall have the power, in the arbitrator's discretion, to award attorneys' fees and the costs of the arbitration proceeding to the prevailing party.
